

SPRING SINGAPORE GRANT

If you are creating or have created an ezyCommerce Account on behalf of a company which:

- (a) is incorporated in Singapore, and in which Singaporean citizens hold at least 30% of the shares; and
- (b) when aggregated with its parent company and its subsidiaries (i.e., considered with other members of its group), has:
 - (i) annual sales of not more than S\$100,000,000; **OR**
 - (ii) not more than 200 employees; and
- (c) currently has an order volume of between 150 and 1500 orders per month,

your company (from here onwards, referred to as “you”) may be eligible for a grant from SPRING Singapore (“SPRING”) to offset up to 70% of the fees payable for the ezyCommerce Services per month (subject to a maximum of S\$3,500/- per month) for a period of up to 6 months.

If you fulfil the criteria above and would like to apply for the SPRING grant to use the ezyCommerce Services, **please tick the box below** (which will be treated as a confirmation that your company fulfils all of the criteria set out in paragraphs (a) to (c) above). We will notify you if you have been successful. [If you are awarded the SPRING grant, it will be paid directly to SingPost eCommerce Pte. Ltd. (“**SP eCommerce**”) by SPRING to offset the fees payable by you for the ezyCommerce Services. You will only need to pay SP eCommerce the outstanding invoice amounts not covered by the grant. You hereby warrant that any information provided to SP eCommerce in relation to your application for the SPRING grant is true, complete and accurate, and undertake to promptly inform SP eCommerce in writing of any changes to this information.

In the event that any of the information which you provide to SP eCommerce or SPRING in relation to your application for the SPRING grant is inaccurate (including as a result of wilful misrepresentation or the giving of intentionally false or misleading statements), SP eCommerce or SPRING may terminate further disbursements of the SPRING grant, and you shall, upon demand, be required to refund and repay to SP eCommerce (which will in turn, return such sums to SPRING) all sums which have been disbursed to or on your behalf as part of the SPRING grant during the period up to and including the date of such termination. **Please ensure that all information and confirmations you provide in relation to the SPRING grant application is correct.**

Notwithstanding anything contained in the General Terms & Conditions in respect of the ezyCommerce Services (as set out at www.ezycommerce.com) if the SPRING grant is awarded to you, you hereby agree to use the ezyCommerce Services, and maintain an ezyCommerce Account for the entire continuous 6 month duration to which the SPRING grant relates.

Please note that there are a limited number of SPRING grants available (which will be awarded on a first-come first-serve basis), and applying earlier for the grant may increase your chances of success.
